SCOPE AND CONTENT NOTE

This finding aid focuses on correspondence originated by and received by the State Supreme Court Clerk. Ranging from 1903 to 1921, the bulk of this correspondence falls in the period prior to 1911. Although some routine business letters have been retained, a wealth of political comments dominates the collection. Such political notables as Edward W. Carmack, Hill McAlister, and William Jennings Bryan are represented here. All correspondence with and by the various judges of the Court has been retained.
