National Library Service Director Visits Tennessee

On October 26, 2004, the staff of the Tennessee Library for the Blind & Physically Handicapped (LBPH) was honored with a visit by Frank Kurt Cylke, Director of the National Library Service for the Blind & Physically Handicapped (NLS), the division of the Library of Congress that oversees LBPH services in all 50 states. Mr. Cylke was accompanied by Jean Moss, NLS's new Digital Project Coordinator. Mr. Cylke & Ms. Moss shared with the LBPH staff and the Tennessee State Library & Archives administration the latest information on the anticipated transition to books on flash memory, currently scheduled to begin in 2008.

Flash memory is the industry standard for handheld devices such as cell phones, digital cameras and palmtop computers. Flash cartridges will be about the size of a credit card and are extremely durable. Most adult titles will fit onto one flash memory cartridge. All of these aspects make flash memory a "perfect fit" for audio books provided by the NLS program.

In preparation for the change in format, NLS conducted a nationwide 82-question survey of 447 patrons to

assess demographic characteristics of users of the LBPH service; current patterns of technology use; self-rating of current equipment and services; physical and cognitive functioning of LBPH users; and benefits of new technology that are most/least important to patrons. Among the results:

- 60% of responding users are over the age of 65;
- 61% are blind or visually impaired;
- 52% have a high school education;
- 29% have used the service for less than two years, while 12% have used the service more than 20 years;
- 56% read daily;
- 90% use players independently and find it very easy to return books, although 49% needed help at first.
- 92% reported no difficulty handling cassettes.

Requested improvements included smaller, lighter players, improved sound quality, and the ability to find one's place after having fallen asleep.

Be Alert for Two-Track Tapes

Many years ago, NLS produced almost 900 titles on two sides instead of four. Some of these titles are still in circulation. They start with RC 06010 and continue through RC 09430.

Often, patrons who receive these older books return them as bad copies. When listening to our older NLS titles, be sure to follow the directions at the end of each tape. The narrator will let you know whether to change the tape or switch the side selector. Both of these recordings will be the commercially produced editions, not recorded by an NLS contractor. Be sure to specify which version you want to read when you order this popular title. The unabridged version is also available in Spanish, **Mi Vida**, RC 58960.

NLS Produces 9/11 Commission Report

The events of September 11, 2001, remain vivid in American hearts and minds. NLS has recently produced *The 9/11 Commission Report: Final Report of the National Commission on Terrorist Attacks Against the United States* as RC 58238 or BR 15396. In the report the nonpartisan commission analyzes facts and circumstances surrounding Al-Qaeda's fatal September 11 attacks on the United States homeland. The report summarizes failures of intelligence and other U.S. agencies before and after that date, and recommends government reorganization to provide a safer, more prepared nation.

How Long Can You Keep Books?

Do you have large print, braille or recorded books checked out that you've been planning to read, but just haven't gotten around to doing it? Are you storing a favorite descriptive video from the library because it was so good you want to watch it again...someday? If you want to read, or re-read that book, there's a good chance someone else wants to read it, too.

The loan period for books borrowed from the library is six weeks. The loan period for videos is two weeks. These loan periods include mailing time. If you can read the date on the side of the mailcard that is addressed to you, the loan period **starts** with that date. It is the date the item was checked out and placed in the mail to you. We can always put that favorite book or video back in your request file and send it to you again. Just call and tell us to do this.

The cassette players are on extended loan to you. This means that you may keep them as long as you actively borrow recorded books and/or magazines from the library. If you are just borrowing large print and/or descriptive videos, you should return any player that may have been loaned to you.
